9:00 a.m. pursuant to notice the Lyon County Commissioners met with the following members present: Commissioners Anderson, Sanow, Crowley and Ritter. Also present: Administrator Stomberg and Attorney Maes. Commissioner Graupmann was absent.

**MSP** to approve the agenda.

**MSP** to approve the consent agenda.

**MSP** to approve the Media Conversion Contract with Fidar Technologies and US Images.

**MSP** to award SP 042-070-009 to ID Signs Solutions, LLC of Glencoe for a total of \$13,234.02 and authorize Board Chair to sign contract.

**MSP** to award SP 042-070-010 to Traffic Marking Service, Inc. of Maple Lake in the amount of \$333,310.20 and authorize Board Chair to sign contract.

**MSP** to approve the winter maintenance agreement with the City of Balaton to perform snow and ice removal for .5 miles of CSAH 27.

**MSP** to approve the Conditional Use Permit for Meadowland Farmers Coop to establish a rural-oriented commercial use with the conditions presented.

**MSP** to approve the Conditional Use Permit for Vande Ag Enterprises to construct a new feedlot with a capacity of 300 animal units or more with the conditions presented. Commissioners Crowley, Graupmann, Ritter and Sanow voted in favor. Commissioner Anderson abstained from voting.

**MSP** to approve the Cooperative Service Agreement with Advance Opportunities for bulky material recycling.

**MSP** to approve the quote from Premium Plant Services for \$4,864.00 per leachate pond, for a total of \$9,728.00.

**MSP** to allow the Environmental Department to seek bids for a shower/restroom facility for the upper campground at Garvin Park.

**MSP** to accept the low quote from DeSmet Weldors & Machine Company for a total of \$10,240.00 for the Manufacturing of the Garvin Park Foot Bridge.

**MSP** to allow A/T Moberg to move funds to keep the Fair Board's account out of the red during the fair.
