## **RESOLUTION NO. 2017-67**

### A PRELIMINARY RESOLUTION LEVYING A PROPERTY TAX FOR THE SUPPORT OF THE INFRA-STRUCTURE REPLACEMENT RESERVE FUND

WHEREAS, the City of Tracy has established an Infrastructure Replacement Reserve Fund pursuant to Minn. Stat. 471.572;

WHEREAS, the Infrastructure Replacement Reserve Fund has been established and codified in Section 10.10 of the City Charter;

WHEREAS, the Infrastructure Replacement Reserve Fund shall be used only for the replacement of streets, bridges, curbs, gutters, sidewalks, trees, and storm sewers;

WHEREAS, pursuant to the Infrastructure Replacement Reserve Fund, the City of Tracy may annually levy a property tax for the support of the reserve fund;

WHEREAS, the City of Tracy has determined that its streets, bridges, curbs, gutters, sidewalks, trees, and storm sewers need replacement;

WHEREAS, the City of Tracy seeks to improve the appearance of the city and improve the infrastructure therein;

WHEREAS, the replacement of deteriorated infrastructure will benefit the city and its citizens;

WHEREAS, to sufficiently fund the Infrastructure Replacement Reserve Fund to make necessary capital improvements within the city, the City of Tracy desires to levy a property tax;

WHEREAS, by levying a property tax to fund the Infrastructure Replacement Reserve Fund, the City of Tracy intends to decrease its reliance on financing to fund projects for the replacement of infrastructure and to decrease citizens' special assessments; WHEREAS, the City of Tracy intends to levy a property tax of *\$53,760.00* on all real property within the City of Tracy to support the Infrastructure Replacement Reserve Fund for the year of 2018;

WHEREAS, the City of Tracy has followed the procedural requirements of Minn. Stat. 471.572 and Section 10.10 of the City Charter in approving this resolution;

WHEREAS, if within ten days after the publication of this resolution a petition is filed with the city clerk requesting an election on the tax levy signed by a number of qualified voters greater than ten percent of the number who voted in the city at the last general election, the tax may not be levied until the levy has been approved by a majority of the votes cast on it at a regular or special election;

# NOW THEREFORE, THE CITY OF TRACY DOES ORDAIN:

1. Pursuant to Minn. Stat. 471.572 and Section 10.10 of the City of Tracy Charter, the City of Tracy hereby levies a property tax of *\$53,760.00* on all real property within the City of Tracy to support the Infrastructure Replacement Reserve Fund for the year of 2018.

2. The proceeds of taxes levied for the support of the Infrastructure Replacement Reserve Fund must be paid into the reserve fund and shall be used only for the replacement of streets, bridges, curbs, gutters, sidewalks, trees, and storm sewers.

3. The City shall report the levy to Lyon County for proper certification for tax purposes.

# ORDINANCE NO. 360 AN ORDINANCE AMENDING CITY CODE SECTION 6.14, SUBD 2 MONTHLY SEWER RATES-AVERAGE MONTHS CHANGE

Subd 2. MONTHLY SEWER RATES. The monthly rates for municipal sewer service in the City of Tracy, Minnesota shall be based on the average winter monthly usage for the months of January, February and March March, April, September and October and computed as follows:

Service charge of \$13.00 an amount in accordance with the yearly rate set by an annual resolution for each use, plus \$13.00 an amount in accordance with the yearly rate set by an annual resolution for each additional use per structure plus \$1.05 an amount in accordance with the yearly rate set by an annual resolution per unit or \$1.38 an amount in accordance with the yearly rate set by an annual resolution per 1,000 gallons based on the average winter monthly usage.

All properties connected to any sewer main not previously assessed or having been subjected to the hook-up charges as described Section 6.12, shall be subject to the current hook-up fee in lieu of an assessment when said line is replaced.
