## NOTICE OF FINAL HEARING

### For the Improvement of and Redetermination of Benefits for County Ditch 14

Notice is hereby given that the final hearing on the pending petition for improvement of County Ditch 14 ("CD 14") and the redetermination of benefits for CD 14 is hereby set as follows:

Wednesday, March 2, 2022 at 1:30 p.m., in the Commissioner Room at the Lyon County Government Center, 607 West Main Street in Marshall, MN.

The purpose of the hearing is to consider the petition for improvement, the engineer's report for the improvement of the main tile and three branches of CD 14, the viewers' reports for the improvement and for the redetermination of benefits, and to determine any separable maintenance.

The following owners of property and governmental entities are affected by the redetermination of benefits of CD 14:

Portions of sections 5, 6, 7, 8, 17, 18, and 20 of Custer Township and portions of sections 1, 12, and 13 of Rock Lake Township in Lyon County. The outlet for this tile system is into an unnamed stream in section 32 of Sodus Township. Fork 1, Branch 1 (aka Branch 1A): from its junction with Branch 1 in the NW ¼ of the NW ¼ of Custer Township section 7 to the north line of the NW ¼ of the NW ¼ of Custer Township section 7 (south of the 151<sup>st</sup> St. Right of Way).

Branch 2: from its junction with the Main in the NE ¼ of the SE ¼ of Custer Township section 6 to its terminus in the SW ¼ of the SE ¼ of Custer Township section 6.

Main: from the outlet in the SE ¼ of the SW ¼ of Sodus Township section 32 to the south line of the NW ¼ of the NW ¼ of Custer Township section 7.

The engineer has submitted and filed a final detailed survey report to the drainage authority. The property owner's report and the viewers' report for the improvement and the redetermination of benefits have been submitted and filed and the petition is pending.

The drainage authority will hear a detailed survey report prepared by the engineer discussing the improvement and separable maintenance. The viewers' report for the improvement and the redetermination of benefits will also be heard.

**MSP** to approve the agenda with the addition of Dispatcher Hire, Extension Committee Appointment and BWSR lease discussion.

**MSP** to approve the consent agenda.

**MSP** to pay \$3,000 for 2022 to the Marshall Area Transportation Group.

**MSP** to give P&Z Administrator permission to seek quotes to repair tile on CD 7.

**MSP** to come out of the Ditch Authority.

**MSP** to adopt a resolution approving Lyon County's application for funding from the 2022 Help America Vote Act grant program.

**MSP** to approve the resolution authorizing the Board Chair and County Administrator to execute an agreement between Lyon County and MN DOT for the lighting of the intersection of Highway 23 and County Road 74.

**MSP** to accept a \$10 donation from Lucas Christoffer to be placed in the DARE account. A thank you will be sent.

**MSP** to approve Task Authorization #12 from Burns and McDonnell for professional services for phase 9B plan at the Landfill.

**MSP** to approve Task Authorization #13 from Burns and McDonnell for professional services for phase 9B plan at the Landfill.

**MSP** to approve the disbursement of the Greater MN Landfill Cleanup Rebates to the counties as listed.

**MSP** to approve the lease with C&B Enterprises for \$14,058.30 per year for 3 years. At the end of the 3 year lease look at the buyout option.

**MSP** to allow Environmental Administrator to request quotes to replace 2 existing Parks front deck mowers.

**MSP** to participate with a full page for the City of Marshall 150<sup>th</sup> Anniversary in the Marshall Independent and spend up to \$1,000. County Administrator Stomberg will work with the Marshall Independent.

**MSP** to approve the hire of Lory Jo Holden as 911 Dispatcher with a starting rate of \$20.41 per hour and a starting date of February 1.

**MSP** to authorize Administrator Stomberg to bring back a lease agreement with BWSR for office space on the 1<sup>st</sup> floor of the Government Center.

**MSP** to retain the law firm of Madden Galanter Hansen, LLP to assist in union negotiations with LELS.
