#### For the Improvement of and Redetermination of Benefits for County Ditch 14

Notice is hereby given that the final hearing on the pending petition for improvement of County Ditch 14 ("CD 14") and the redetermination of benefits for CD 14 is hereby set as follows:

Wednesday, March 2, 2022 at 1:30 p.m., in the Commissioner Room at the Lyon County Government Center, 607 West Main Street in Marshall, MN.

The purpose of the hearing is to consider the petition for improvement, the engineer's report for the improvement of the main tile and three branches of CD 14, the viewers' reports for the improvement and for the redetermination of benefits, and to determine any separable maintenance.

The following owners of property and governmental entities are affected by the redetermination of benefits of CD 14:

Portions of sections 5, 6, 7, 8, 17, 18, and 20 of Custer Township and portions of sections 1, 12, and 13 of Rock Lake Township in Lyon County. Fork 1, Branch 1 (aka Branch 1A): from its junction with Branch 1 in the NW ¼ of the NW ¼ of Custer Township section 7 to the north line of the NW 1/4 of the NW 1/4 of Custer Township section 7 (south of the 151st St. Right of Way)

Branch 2: from its junction with the Main in the NE ¼ of the SE ¼ of Custer Township section 6 to its terminus in the SW 1/4 of the SE 1/4 of Custer Township section 6.

Main: from the outlet in the SE 1/4 of the SW 1/4 of Sodus Township section 32 to the south line of the NW ¼ of the NW ¼ of Custer Township section 7.

The engineer has submitted and filed a final detailed survey report to the drainage authority. The property owner's report and the viewers' report for the improvement and the redetermination of benefits have been submitted and filed and the petition is pending.

The drainage authority will hear a detailed survey report prepared by the engineer discussing the improvement and separable maintenance. The viewers' report for the improvement and the redetermination of benefits will also be heard.

The Lyon County Board of Commissioners passed a resolution that will allow turkey hunters sole access to Garvin Park during the 2021 Spring Turkey Hunting Season. Garvin Park will close to all other activities from one-half hour before sunrise to noon for Season A & B, from April 13, 2022 through April 26, 2022. Garvin Park will be open to those hunters possessing a MN DNR license and Garvin Park Hunting Permit for Season A-B. No hunting will be allowed after noon at the park. Archery Hunting for wild turkey will be open during season C, D & E in Garvin Park, allowing access for all recreational activities during seasons C, D & E.

All turkey hunters will be required to obtain a hunting permit from the Lyon County park staff prior to hunting in Garvin Park along with their valid MN DNR license. Garvin Park hunting permits may be obtained from park staff, Monday through Friday from 8 a.m. to 4:30 p.m. at the Public Works building or by calling to make an appointment. You will need your MN DNR license, photo ID and your license plate numbers for the vehicle or vehicles that you will be driving to the Park. Anyone who does not possess a Garvin Park hunting permit during the closed times will be asked to leave until after noon.
