# **Project Descriptions and Process Information**

**Certificate of Need.** The Applicants cannot construct the Project until the Commission analyzes whether the Project is needed to ensure adequate, reliable, and efficient energy supply and issues a certificate of need. On August 15, 2023, the Applicants filed an application for a certificate of need with the Commission for the proposed 345 kV Brookings County to Lyon County and Helena to Hampton Second-Circuit Project.

According to the Applicants, the Project would reduce energy costs by relieving the current transmission congestion in the Project area and is expected to increase access to low-cost, carbon-free, renewable energy, provide economic benefits; strengthen the regional grid, support wind generation facilities in Minnesota, North Dakota, and South Dakota, and advance the State's energy policy.

The total length of the Project is 98.5 miles in two segments between the Brookings Substation in White, South Dakota, and the Lyon County Substation near Marshall, Minnesota, and the between the Helena Substation in Scott County, Minnesota, and the Hampton Substation near Hampton, Minnesota. The Project would entail reconfiguration and addition of one structure to the existing line at the Steep Bank Substation, and rerouting HVTL around the Chub Lake Substation, including the addition of two new structures. The Project also includes installation of eight new poles near the eastern end of the Project. The Project modifications would take place within existing rights of-way.

**Environmental Report.** Before the Commission can decide on the certificate of need application, the Department of Commerce (Department) must prepare an environmental report (ER). The ER is a written document that describes the potential human and environmental impacts of the proposed Project, alternatives to the Project, and methods to mitigate anticipated adverse impacts. The Department will release the ER on March 22, 2024. The ER will be available in eDockets and on the Department's website:

Minor Alteration. The Commission must approve a minor alteration to the original Brookings to Hampton HVTL route permit before the Project is constructed. In November 2023, the Applicants filed their application for a minor alteration to the route permit for the Brookings to Hampton HVTL. The Commission can approve the minor alteration only if the Commission determines that the Project does not result in significant human or environmental impacts. The Commission may approve the minor alteration but impose reasonable conditions on its approval. These conditions may include measures to limit the human and environmental impact of construction and operation of the Project.

Minnesota Statutes and Rules. The certificate of need is governed by Minnesota law, including Minnesota Statutes Section 216B.243, and Minnesota Rules Chapters 7829 and 7849, specifically Rules 7849.0010 to 7849.0400 and 7849.1000 to 7849.2100.

The minor alteration application is being reviewed by the Commission pursuant to Minnesota Rule 7850.4900. The Commission considers the factors cited in Minnesota Rules 7850.4100 to evaluate the significance of potential human and environmental impacts of the minor alteration.
