MSP to accept the Island Lake 27 resolution. Roll call vote, motion carried.


MSP to approve changing the listed ancillary insurances to Lincoln Financial.

Minnesota's youth deer season will take place statewide Oct. 17-Oct. 20. The season coincides with statewide teacher workshops, so many Minnesota students don't have school during the youth season. To participate, youth must be 10-17 years old and have a deer license. Participant numbers are not limited and there is no special permit, so parents should obtain a regular deer hunting license for each youth who will be hunting. Youth may not tag antlerless deer or legal bucks taken by another individual. An adult parent, guardian or mentor must accompany youth ages 10-13.

All hunters and mentors, regardless of whether they are participating in youth deer season, must follow blaze orange/pink clothing requirements. Fabric or synthetic ground blinds on public land must have a blaze orange safety covering on top of the blind that is visible from all directions, or a patch made of blaze orange that is at least 144 square inches (12x12 inches) on each side of the blind.

Adults may not hunt, unless they are in an area open during the early antlerless season and have a valid license. Complete youth season details are available on the Minnesota DNR youth deer season webpage (mndnr.gov/hunting/deer/youth. html).

In the Matter of the Certificate of Need and Route Permit Applications for the Minnesota Energy Connection Project in Sherburne, Stearns, Kandiyohi, Wright, Meeker, Chippewa, Yellow Medicine, Renville, Redwood, and Lyon Counties in Minnesota

PLEASE TAKE NOTICE that the Minnesota Public Utilities Commission (Commission) will hold public and evidentiary hearings on the applications of Xcel Energy for a certificate of need and a route permit for the Minnesota Energy Connection Project, a new approximately 171- to 174-mile 345-kilovolt (kV) double-circuit transmission line between Sherburne and Lyon counties (MNEC Project). The public meetings/hearings also provide an opportunity to comment on the draft environmental impact statement (draft EIS) prepared by the Minnesota Department of Commerce (Department) for the MNEC Project. The proposed MNEC Project includes the following:

- A new 345-kV double-circuit transmission line between the existing Sherco Substation in the city of Becker in Sherburne County and a new substation (Garvin Substation) proposed near the city of Garvin in Lyon County. Xcel Energy has proposed two route alternatives: the Purple Route, which is 171 miles in length, and the Blue Route, which is 174 miles in length. Xcel has also proposed four connector segments that would provide options to utilize different portions of each alternative route, as appropriate.
- A new 3.1-mile single-circuit 345-kV transmission line co-located on existing structures between the existing Sherco and Sherco Solar West substations in the city of Becker.
- Modifications to the existing Sherco and Sherco Solar West substations, a new voltage-support substation, and a new intermediate substation.

Xcel Energy has requested a route width of 1,000 feet and a final rightof-way width of 150 feet, with the exception of the areas around the substations and conservation easements where the route width would range from 0.3 mile to 1.25 miles to enable flexibility in routing.

In addition to the routes proposed by Xcel Energy in its application, 48 alternative route segments, 11 alternative route connectors, and four alignment alternatives were evaluated in the draft FIS prepared for the proposed MNEC Project. The draft EIS also evaluated system s to the proposed MNEC Project which include more generation (nuclear or natural gas) at the Sherco plant, new generation plants (nuclear, natural gas, solar, or wind) closer to the Sherco plant, underground transmission line construction, and a no-build alternative.

The formal public meetings/hearings will be conducted by an administrative law judge with the Office of Administrative Hearings, who will provide the Commission with findings of fact, conclusions of law, and a recommendation.

The purpose of the public meetings/hearings is to obtain public input on the proposed MNEC Project, the drafts EIS, and compile the record for the Commission to consider in making a final decision on the certificate of need and route permit applications. Specifically, interested persons will have the opportunity to: (1) ask questions of state staff and the applicant; (2) offer oral and written comments on the merits of the proposed project and on the draft EIS; and (3) suggest possible conditions to be considered for inclusion in a certificate of need and a route permit.

- Comments received at the hearings and during the comment period will be used to: 1) develop the final EIS, to the extent that comments relate to the draft EIS; and 2) inform the record to help the Commission make its final decision.
- The information presented will be the same at all in-person and online hearings.
- The hearings will end when all attendees have had the opportunity to comment and all other business has been concluded, or the scheduled end time of the hearing, whichever occurs first.
- Members of the public may participate without the necessity of intervening as a party; representation by legal counsel is permitted but not required.


